The applications of the following candidates have been accepted for admission to the 04 Years LL.B Program, of the University Law College, Quaid-e-Azam Campus, Lahore, for the ensuing academic session with the following conditions:-

1. Any Candidate who is found (at any time) to have obtained admission by making any mis-statement in the admission form or by willful concealment in any material fact particularly about Marks, Division, Previous admission to the University Law College etc, his/her admission shall be cancelled with immediate effect and a criminal proceeding shall be initiated against such candidate.
2. The Bank Challan forms shall be issued by the office from **02-09-2025 to 04-09-2025**. The Challan Form shall be deposited within Banking Hours till 04-09-2025. Those who do not deposit their dues within the prescribed time shall not be eligible for admission.
3. Candidates are required to submit original Matric, F.A./F.Sc. Degree / Result Card, Migration Certificate, LAT and P.U Entry Test Result Card , three passport size pictures and an affidavit on Rupees 200 E-Stamp Paper duly Attested by Oath Commissioner to **Malik Mumtaz Ahmad,**
Administrative Officer (Semester Cell).
4. The candidate must provide equivalence/verification of their academic documents from the Inter Board Committee of Chairman (IBCC) at the time of admission.
5. Those candidates who have applied on the basis of Hafiz-e-Quran shall have to qualify the Verbal Test of Holy Quran before issuance of the Challan Form.
6. Candidates shall pay their dues (**Rs.70350/- first semester**) in the Habib Bank Limited (Quaid-e-Azam Campus Branch) after obtaining **CHALLAN FORM** from the University Law College **Account Office (Room No.03)**
7. The Candidates are also required to submit hard copy of online form/original challan form of Rs.500/- in the office.
8. The College reserves the right to correct any typographical errors, omission, etc.(if any)
9. The Applicants, who could not qualify the Law Admission Test (LAT) till 18/08/2025 (the closing date) are not eligible for admission in 04 years LL.B. Program as they have mentioned bogus marks of LAT Admission in their online admission forms.

Note: *On account of limited Punjab University Hostel Seats, only few newly admitted students will be offered Hostel facility in Academic Year 2025, as per policy of the University.*
